According to our Constitution, alternate methods of voting are available if the Nominating Committee so chooses. This year the Committee has invoked the use of absentee ballots. If you are a 2018 adult member (age 18 as of Jan 1, 2018) unable to attend the November 7, 2018 meeting and want to vote, you can request an absentee ballot by sending the form below. Only a voting member may request their ballot, and only one ballot will be sent per member as requested. Requests must be clearly postmarked **on or before October 24, 2018**. Once the ballot is sent, your name is removed from the roster of eligible voters for the November 7 meeting, and you are committed only to the absentee method of voting in this election. A ballot will be sent to you immediately and it must be returned **by mail** to the address provided and must be clearly postmarked **on or before November 1, 2018** or **brought to** the November 7, 2018 meeting by the voting member. If multiple adult members are casting votes, they **MUST** be mailed in separate envelopes. Please **DO NOT** send more than one member's ballot in an envelope. Absentee ballots will be opened and counted at the November 7, 2018 meeting. **Any ballot not received before November 7, 2018 or requested according to this procedure will be marked invalid and will not count.**
